**MINUTES OF THE 37<sup>th</sup> ANNUAL GENERAL MEETING (AGM) OF ISAMPE**

**10<sup>th</sup> November 2023**

The **37<sup>th</sup> Annual General Meeting (AGM)** of ISAMPE was held at the **Dr. V M Ghatage Convention Centre, HAL, Marathahalli, Bangalore-37** on **10<sup>th</sup> November 2023(Friday)** from **9:30 hrs to 15:30 hrs**. The detail program schedule is enclosed in **Annexure-1**.

Business session of the AGM was held in the afternoon of 10<sup>th</sup> November 2023 and the agenda for the meeting as given in the programme (**Annexure-1**) was followed.

**Record of discussions:**

**1. Welcome & Address by the President**

Dr. S. Rajagopal, President-ISAMPE welcomed all the members for the Business Session. He appreciated members for their participation in large numbers in the AGM and thanked Executive Director(FMD), HAL for permitting Dr. V M Ghatage Convention Centre for conducting the 37<sup>th</sup> AGM.

## **2. Confirmation of Minutes of 36<sup>th</sup> AGM**

## **7. Appointment of Auditor for the Year 2023-2024**

AGM also approved request of the auditor to increase audit fees and introduction of UDIN fees for the audit consolidation report.

## 8. Plan of Activities for 2022-23

Mr. Sandeep Kumar Panigrahy, Secretary- ISAMPE addressed the General Body and discussed about the plan of action for the year 2023-24, mainly with respect to following:

- **Membership Photo ID Cards to ISAMPE Life members:** The process for issue of Photo ID Cards to ISAMPE Life members is continuing and as of now close to 600 ID cards are printed and handed over to the respective individuals. This process will be continued till the completion for all the members. It is also initiated for a fresh member the ID card will be issued along with the Life membership certificate.
- Secretary further sought chapter's support in updating their membership address and requested Chapters to provide **single point contact** (either **Chapter Secretary or Jt. Secretary**) to interact with him and to provide members photo and contact details so that he can issue membership cards to them.
- ISAMPE understands the importance of imparting education and exposures to the engineering student community. In this regard, ISAMPE has instituted a Student Chapter in BMSCE Bangalore. The students are given necessary exposure to composite technologies by through workshops, lectures and visits to relevant facilities. Request from few engineering colleges in Bangalore like MVJCE, BMSIT, etc to open Student Chapters being referred to Chairman ISAMPE Bangalore Chapter for framing guidelines of operating student chapters at these engg. colleges in consultation with past Presidents of ISAMPE like Dr S Sankaran ,Dr D Saji & Dr S Rajagopal. Similar student chapter is also being planned to be set up in Pune. AGM appreciated this idea and requested other Chapters to follow this.
- ISAMPE would like to improve the industrial participation in the ISAMPE activities. In this context, increasing corporate membership is planned. Corporate membership of industries can be directly promoting corporate activities. So Vice President is requested to initiate this drive.

- AGM requested ISAMPE to increase its Professional Life membership to 2500 by this FY through membership drives in various academic, R&D labs and industries. Secretary is requested to come out an action plan for this.
- Involvement of the student members in the ISAMPE activities though organizing the workshops and visits to the industries.
- ISAMPE plans to conduct a NECTAR workshop this year and a Committee under Chairmanship of Dr M Ramesh Kumar Head ACD CSIR-NAL will identify a suitable topic for the workshop in consultation with President & EC of ISAMPE .
- ISAMPE awards committee decided to have 2 awards under ISAMPE award for Smart Materials Systems and Technology Development . One for Materials development & other for Technology Development for aerospace applications.
- Mrs Raksha Zaveri Guli Enterprises,Bangalore is enhancing Shri Vijay Zaveri award for excellence in technical support to Rs10,000/- from next year. In this connection, she is donating Rs 2,00,000/- to ISAMPE as Corpus fund for the annual award.

## INDEPENDENT AUDITOR'S REPORT

To

The Trustees of Indian Society for Advancement of Materials and Process Engineering,  
Bangalore Main body.

### Qualified Opinion

We have audited the accompanying financial statements of Trustees of Indian Society for Advancement of Materials and Process Engineering, Bangalore Main body ("Trust"), which comprise the Balance sheet as at 31st March 2023, the Income and Expenditure and Statement of Receipts and Payments for the year ended on that date and a summary of significant accounting policies.

In our opinion and to the best of our information and according to the explanations given to us, except for the effects of the matters described in the Basis of *Qualified Opinion* section of our report, the accompanying financial statements give a true and fair view as at 31<sup>st</sup> March 2023, in conformity with the accounting principles generally accepted in India.

### Basis for Qualified Opinion

1. The investment held by the trust with Unit Trust of India is carried at Rs 6,66,230/- on the Balance sheet as at 31st March 2023. We were unable to obtain sufficient audit evidence about the carrying amount of these investments. Consequentially, we were unable to determine whether any adjustments to these amounts were necessary.

We conducted our audit in accordance with the Standards on Auditing (SAs) issued by the Institute of Chartered Accountants of India. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the financial statement section of our report. We are independent of the trust in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India and we have fulfilled our other ethical responsibilities in accordance with the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

### Responsibilities of Management on the Financial Statement

The trustees are responsible for the preparation of these financial statements that give a true and fair view in accordance with the accounting principles generally accepted in India. This principle includes design, implementation and maintenance of internal financial controls, relevant to the preparation and presentation of the state of affairs and, receipts and payments that give a true and fair view and are free from material misstatement, whether due to fraud or error.

### Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the Financial Statements together with other statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. 




